Author Agreement

This author agreement sets out the terms governing how Scientific Journal Publishers Limited, NZ company no. 1151284 (we, us) will publish and otherwise deal with your manuscript. Before we publish your manuscript, we ask that you and your co-authors (if any) read and sign this author agreement.

By signing this author agreement, you are entering into a legally binding contract with us. Please read it carefully.

We look forward to receiving a signed copy of this author agreement, and to working with you to finalize and publish your manuscript.

1. Agreement to publish

- 1.1. We agree to publish a final version of your manuscript in *Social Behavior and Personality: An international journal (SBP Journal)*, provided that you and your co-authors (if any) firstly satisfy the conditions listed in clause 2 below.

2. Conditions of publication

- 2.1. As a condition to our publication of your manuscript, you agree to:
 - (a) sign and return a copy of this author agreement to us;
 - (b) revise your manuscript in accordance with any instructions we have provided you in our conditional acceptance letter;
 - (c) at the date we specify, pay us, in full cleared funds, the amount specified in the invoice for article publication charges (APCs) plus GST if applicable;
 - (d) comply with any other reasonable directions we provide you regarding your manuscript prior to final publication.

3. You assign us the copyright in your manuscript

- 3.1. You hereby assign to us absolutely all of the current and future rights, title and interest that you have in your manuscript, and to the intellectual property in that manuscript. You agree that this clause operates as an assignment of present and future copyright.

4. Your ongoing rights to your manuscript

- 4.1. We grant you a perpetual, non-transferable, worldwide, royalty-free, non-exclusive licence to:
 - (a) from the publication date, personally distribute your manuscript in physical or electronic copy to interested individuals;
 - (b) from the publication date, deposit your article into an institutional repository, with no embargo;
 - (c) upload your original manuscript to pre-print servers;

Provided that, in each case, you give us fair attribution and continually comply with the terms of this author agreement.

- 4.2. If we offer you the Fast Track Service, then you may have your manuscript published in advance on IngentaConnect, provided that you firstly pay us any relevant Fast Track Service Fees.



- 4.3. You may request that we make your published manuscript open access. We will consider your request but are under no obligation to fulfil it. If we choose to make your published manuscript open access, we will notify you. We will also notify you of any new licence terms that apply.
- 4.4. Unless we expressly state otherwise, any new open access licence terms will not supersede this author agreement, which will remain in force.

5. Limitations

- 5.1. This author agreement does not give you any right, title, or interest in the manuscript, except the rights of use specifically set out in clause 4. In particular, you must not, without first obtaining our express written permission:
 - (a) upload your manuscript on ResearchGate or any other similar general research distribution websites;
 - (b) take any action to commercialize or monetize your manuscript.

6. Your warranties in relation to your manuscript

- 6.1. You warrant and affirm that your manuscript:
 - (a) is your own original work, either alone or as a co-author with others;
 - (b) is not currently under consideration by any other publisher;
 - (c) has not been published elsewhere, whether as a whole or in part;
 - (d) does not infringe the intellectual property rights, privacy rights, or other rights of any third party;
 - (e) does not contain any material that is, or could be reasonably considered to be, unlawful, defamatory, misleading or deceptive or likely to mislead or deceive;
 - (f) you have obtained all necessary approvals necessary for us to publish your work, including external approvals from your institution;
 - (g) includes references to or extracts of third-party material only to the extent legally permitted by the “fair dealing” provisions of any applicable copyright laws, or as otherwise permitted by law.
 - (h) has not been *substantially* generated by means of artificial intelligence software.
- 6.2. If we reasonably suspect that you have breached any of the above warranties, or any other term of this author agreement, we may retract our offer to publish your manuscript or, where we have already published your manuscript, withdraw your published manuscript from



circulation. When making decisions under this clause 6, we will take into account the COPE guidelines on publication ethics.

7. Your general warranties

7.1. You warrant that:

- (a) you have all necessary rights and authority to enter and perform this author agreement.
- (b) you have all necessary rights and authority to grant the assignments that you purport to grant under this author agreement.

8. You may be required to indemnify us

- 8.1. As far as permitted by law, you agree to defend, indemnify, and hold us harmless from all liabilities, claims, losses, costs and expenses that we suffer or reasonably incur in connection with any claims that our use of your manuscript infringes the rights of any third party.
- 8.2. However, you will not be liable under this clause to the extent that we have caused or contributed to such losses through our own negligence, breach of these terms, or unlawful conduct.

9. Your rights to be named as author continue

- 9.1. You have moral rights to be named as the author of your work. We do not require that you waive these rights. When we publish your manuscript, we will ensure that you and your co-authors (if any) receive appropriate attribution.

10. General terms

- 10.1. All payments made in connection with our potential or actual publication of your manuscript must be made without deduction or set-off.
- 10.2. This author agreement represents the complete agreement between you and us concerning your manuscript, and supersedes all prior agreements and representations, warranties or understandings between you and us regarding the same subject matter.
- 10.3. You will do all things and execute all documents necessary to give effect to your obligations under this author agreement. You agree to sign all documents (including (without limitation) assignment deeds or assignment agreements) necessary to confirm our ownership of the manuscript, and any intellectual property in it, in connection to any jurisdiction.



- 10.4. This author agreement is governed by New Zealand law. You submit to the non-exclusive jurisdiction of the courts of New Zealand in relation to all disputes arising out of or in connection with these terms.
- 10.5. No variation to this author agreement will be effective unless it is in writing and signed by authorised representatives of each party.
- 10.6. You may not assign, novate, or otherwise transfer your rights or obligations under this author agreement to any other person without first obtaining our written consent.
- 10.7. This author agreement may be executed in any number of counterparts, including scanned email copies.

11. Definitions

11.1. In this author agreement:

- (a) “**Intellectual property**” includes (without limitation) copyrights, design rights, and other intellectual property rights;
- (b) “**Institution**” means the university or tertiary institution that you attend, whether as a student, staff member, or otherwise;
- (c) “**Institutional repository**” means the digitized internal organization database of your institution;
- (d) “**Manuscript**” means the manuscript you have provided us for potential publication in *Social Behavior and Personality: An international journal (SBP Journal)*, and includes all:
 - earlier versions, drafts, or prototypes of your manuscript; and
 - further versions of your manuscript prepared after this author agreement is signed, up to *and including* the final article that we publish;
- (e) “**Publication date**” means the date that we publish your manuscript in *Social Behavior and Personality: An international journal (SBP Journal)*.
